# Unveiling the UFO Whistleblower Claims of David Grusch

David Grusch, a former U.S. military intelligence officer, has made public claims about a highly secretive UFO recovery program maintained by the U.S. federal government. 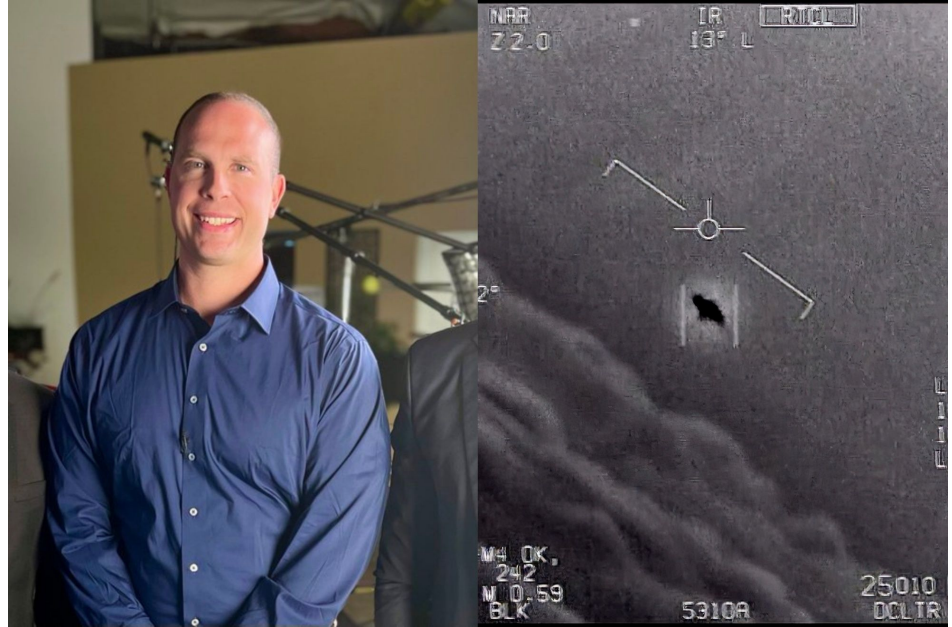
# UFO Whistleblower Interview Recap
