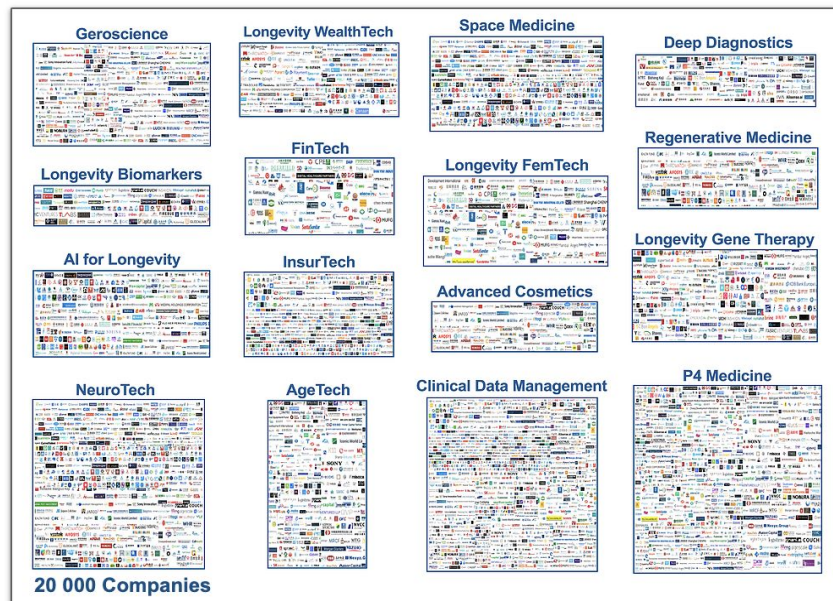

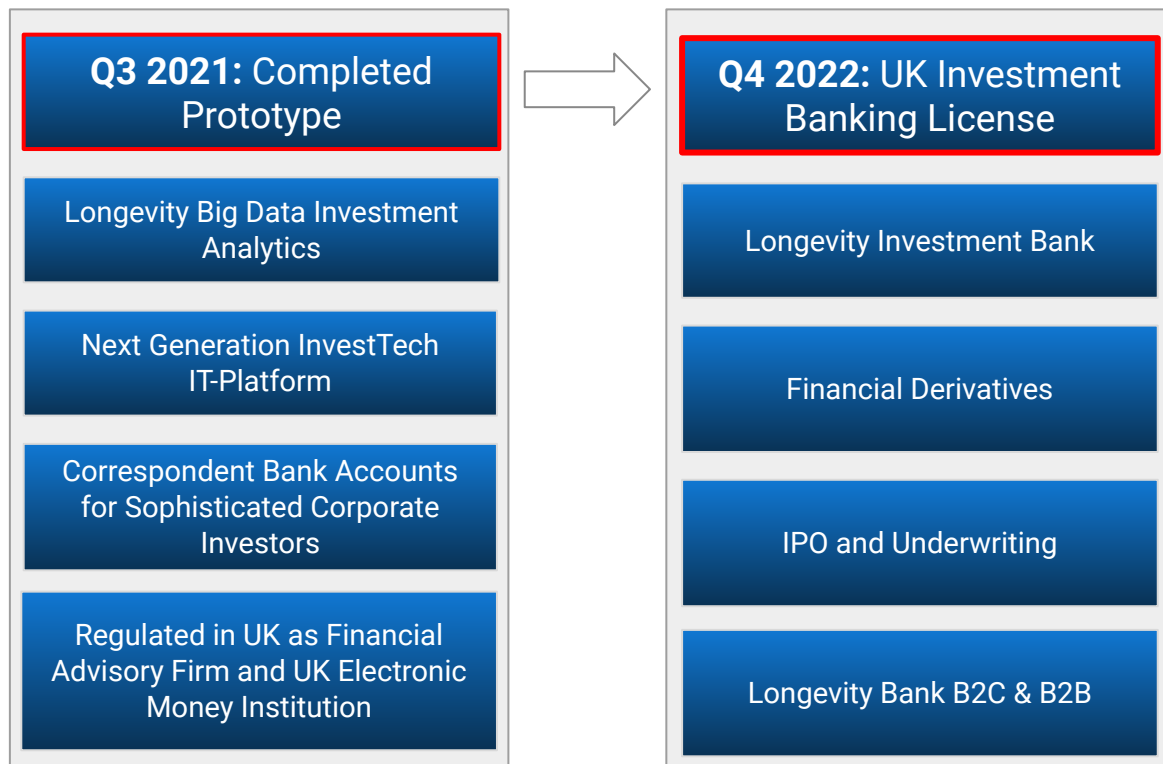

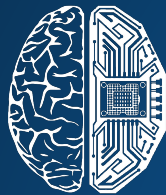


From Financial Advisory Firm to Full Investment Bank

Longevity Financial Advisors Ltd is currently developing its MVP InvestTech IT-Platform, which will be released in **Q3 2021**. At the proof of concept stage, the Platform is operating under the UK Regulatory Framework, having secured authorisation as Appointed Representative of the FCA regulated Razlin Limited, as well as an agreement with an FCA regulated Electronic Money Institution for authorisation to issue correspondent bank accounts.

In the meantime, the company is in the process of applying for a full banking license in the UK. The license is expected **Q4 2022**. Once secured, Longevity Financial Advisors Ltd will evolve its services so as to resemble a full-scope investment bank with retail banking activities.

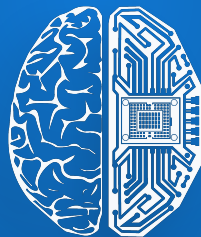
